The MIAMI VALLEY CROSS COUNTRY SKI CLUB was organized with the express purpose of providing a variety of opportunities for those interested in learning and developing skills in the sport of Cross Country Skiing.

MEETINGS SCHEDULE: The club meets on the first Saturday morning of each month from October through April. A coffee social starts at 9:30 A.M. and the formal meeting starts at 10:00 am. Attendance at each monthly meeting is important since, in addition to regular club business, trip plans are discussed and interesting speakers and programs relating to the sport of X C skiing are presented.

CLUB ACTIVITIES: From December through March trips are planned as a group activity to parks and ski touring centers in a multi-state area. Day trips are also planned and at least one major extended trip outside the immediate area is scheduled. Summer and Fall activities are planned which may include camping, bike tours, white water rafting, picnic and other group outings. A club newsletter is published on a regular basis and is e-mailed to each active member.

MEMBERSHIP CLASSIFICATIONS: Annual Individual and Family Memberships are offered. The Membership Year is from January through December. Those joining after April 15th will be admitted for one half the regular membership fees. Memberships are renewed each year in the fall.

By signing this Liability Release, I hereby certify that I am cognizant of those risks and dangers.

I further understand and agree that neither The Miami Valley Cross Country Ski Club, nor, the officers, nor the members shall be held liable in any way for any occurrence related to my participation in any activity in any way related to The Miami Valley Cross Country Ski Club, including any activity in connection with any trip, or event, which may result in my injury, death or other damage to me or my family, executors, administrators, heirs or assigns.

I further hereby release the aforementioned parties from all claims which could have otherwise been asserted by me or on my behalf.

I further hereby personally voluntarily assume all risks and all known dangers as well as all unknown dangers in any way connected with cross country skiing, ski trips or related club activities for any harm, injury or damage which might befall me while participating in said activities, including but not limited to all risks connected therewith, whether foreseen or unforeseen.

I further state that I am of legal age and legally competent to sign this Liability Release Agreement. I further affirm that I understand the terms contained in the Liability Release and Indemnity Agreement are contractual and not merely recital, and that I have signed this document of my own free act and will.

I further hereby agree and confirm that my subsequent annual membership renewals, if any, shall when made, reconfirm my acceptance and continued agreement with all provisions of this Liability Release Agreement.
